Transportation Contract (2010-2011)

(Between the School and the Parent)

The following contract will confirm the transportation arrangements made between **Ahlul-Bayt Islamic School** (herein also referred to as **School**) and the parents of the students who will be using the school bus (herein referred to as **Parent** or **Parents**);

Terms (Dates & Days):

Ahlul-Bayt Islamic School has made a commitment with **Boudria Transportation** (represented by Mme Johanne Lécuyer) for the 2010-2011 school year. In order for the **School** to keep its commitment, we are required to have a contract with the **Parents** for the same period (2010-2011 school year).

Boudria Transportation committed to offering their services to **Ahlul-Bayt Islamic School** for the entire school year commencing **August 26th, 2010** and ending **June 16th, 2011**. Transportation will be offered each school day except on statutory holidays, PD days, school holidays, and Parent-Teacher Interviews. Dates can be found at the beginning of your child's agenda, and any changes will be communicated by the **School** in advance.

Cancellation:

Both, **Ahlul-Bayt Islamic School** and **Boudria Transportation** may cancel this agreement or terminate the transportation services by giving a thirty (30) days advance notice in writing.

Parents, however, MAY NOT CANCEL the bus service if the School believes that Boudria Transportation (Mme. Lécuyer) is offering a good service.

Two options are available to the Parents for modifying their bus services:

1. **Parents** may find other **Parents** willing to take over their existing contract for the remaining of the year. This arrangement must be approved by the **School** before taking effect.
2. A **Parent** may stop using the bus service but honor this contract by continuing to cover all required payments to the **School** for the remainder of the school year.

The School may decide to terminate the bus transportation services if the number of students registered for such services is not sufficient.

Scope of Work:

Boudria Transportation will supply a 22 passenger school bus. **Mme. Lécuyer** will arrange the routes with times and stop locations as supplied and approved by the **Ahlul-Bayt Islamic School**.

Student Conduct:

Mme. Lécuyer and **Ahlul-Bayt Islamic School** reserve the right to refuse or suspend transportation privileges to anyone who demonstrates poor conduct on the bus and does not follow or respect the bus rules.

The bus rules put in place by **Ahlul-Bayt Islamic School** are used by all bus companies for the safety of children.

Weather and Cancellations:

Mme. Lécuyer may cancel the bus services due to bad weather or unsafe road conditions, whether or not the school is open on that particular day. Also, bus students may return home earlier than the scheduled time if weather forecast deems that to be necessary for safety reasons.

Rates & Payment(s):

Parents agree to pay **Ahlul-Bayt Islamic School** a fixed monthly transportation fee by the **first of each month** for the full school year. This is necessary so that the **School** can honor its contractual commitment and continue to make payments on time. **This price is based on the assumption that 22 students are registered for the bus services. The School reserves the right to cancel the bus services, increase or decrease the monthly payment based on the number of registered students.**

Please note:

**This contract applies to the entire school year, and the transportation fee is for the entire year
Parents are expected to pay for the full school year.
This is definitely NOT a monthly fee system.**

For your convenience, however, we offer a monthly payment option.

Payments may be made in monthly **post-dated cheques** that are due on the **first of each month**.

Payments can also be made in **cash** and are due on the **first of each month**.

Absences and Punctuality:

All students with accompanying **Parents** must be ready outside 5 minutes before designated pick up time.

Parents must also be at the bus stop 5-7 minutes before designated drop-off time.

If your child is sick and you are not planning to send him/her to school then you are asked to call **Mme J. Lécuyer** at **613-769-8748** (cell):

- Before 8:00 P.M. the day before, or
- Before 7:00 A.M. on the same day, or
- Meet the bus driver at the designated pickup time and location to inform him/her.
